LATE ROLLOVER CERTIFICATION INFORMATION

Pursuant to the Internal Revenue Service (IRS) Revenue Procedure 2020-46, I certify that this contribution missed the 60-day rollover deadline for the reason(s) listed below under Late Contribution Reason.
